General Comments

The analytical procedures used by ALS have been developed from established internationally recognised procedures such as those published by the USEPA, APHA, AS and NEPM. In house developed procedures are fully validated and are often at the client request.

Where moisture determination has been performed, results are reported on a dry weight basis.

Where a reported less than (<) result is higher than the LOR, this may be due to primary sample extract/digestate dilution and/or insufficient sample for analysis.

Where the LOR of a reported result differs from standard LOR, this may be due to high moisture content, insufficient sample (reduced weight employed) or matrix interference.

When sampling time information is not provided by the client, sampling dates are shown without a time component. In these instances, the time component has been assumed by the laboratory for processing purposes.

Where a result is required to meet compliance limits the associated uncertainty must be considered. Refer to the ALS Contract for details.

- Sample exposure period is 110 days which is outside the typical exposure period of 30 +/- 2 days as per AS3580.10.1.
- No copper sulfate correction was applied to sample(s) 001
- The dust gauge for sample 002 was full when received by the laboratory. It may have overflowed in the field. Results for this gauge are thus reported on an 'as received' basis. No algacide correction has been applied.
- For dust analysis, the Limit of Reporting (LOR) referenced in the reports for deposited matter parameters represents the reporting increment rather than reporting limit.
